


## Idaho High School Athlete Health and Safety Meeting

JUNE 3, 2026 BOISE, ID

Team Up for Sports Safety (TUFSS) project is an initiative to support athletic safety in secondary school athletics working to be able to drive changes and adoption of policies proven to reduce catastrophic sport injury across the United States and Canada (<https://koreystringer.institute.uconn.edu/tufss/>).

Currently, The Idaho TUFSS planning committee and the Korey Stringer Institute are inviting Idaho stakeholders that include state high school athletic association, representation from the state athletic training leadership, other medical groups (physicians, EMS, etc), high school administrators, statewide leadership from Idaho coaches association, legislators and others to meet in Boise, ID on June 3, 2026 to discuss health and safety policy in Idaho specifically catastrophic injury in high school sport.

# Athletic Trainers License Compact


GOVERNMENTAL AFFAIRS

Our association has chosen to pursue an Athletic Training License Compact. This decision was made with the assistance of the Board of Certification and The Council of State Governments, within the National Center for Interstate Compacts. Prior to the new year, we have been meeting with these fellow organizations, as well as the rest of the NWATA states, to gather information, answer questions and create a plan for the potential of an AT License Compact in Idaho. We have also notified the Division of Occupational and Professional Licenses (DOPL) and intend to meet with them as well. There is a lot to be done in the next couple of months and we will keep our membership updated as we progress. For those of you who are not sure what an Athletic Training License Compact is or how it would benefit our Idaho athletic trainers, and ultimately patients, please take a look at the helpful website ATCompact.org. 


## Third Party Reimbursement Update

## NavigATe: The D10 Mentorship Initiative Launches!

On behalf of the NWATA and IATA Early Professionals Committee, we are excited to announce the launch of NavigATe, our new mentorship pilot program. This initiative will run from January through May 2026 and is designed to foster meaningful connections, professional growth, and support within D10.

Interested in joining NavigATe in the future? Applications for the next cohort will open in May 2026 and will be available for both mentees and mentors. New graduates are highly encouraged to apply and take advantage of this opportunity to build confidence and expand networks in the early stages of their careers.



The goal of NavigATe is to help early-career athletic trainers accelerate their professional growth, through guidance, shared wisdom, experience and valuable support. It is a concrete method for early professional to navigate networking and to connect with mentors they may not otherwise have a chance to interact with.

Requirements for the program is again a 1 year commitment (minimum) with an initial meeting/call. Following will be weekly check ins however the individuals deem most fitting i.e. text/email/coffee/walk. Following the program there will be an exit survey.


Mentor: BOC certified for >5 years
